### Terms of Contract:

1. The breeder guarantees that to the best of her knowledge, this animal is in good health and free from communicable disease at the time of purchase. The breeder guarantees that the buyer will receive all health records pertaining to this animal at the time of purchase.
2. The breeder guarantees that the above named Australian Cattle Dog is purebred and registerable with the American Kennel Club.
3. The breeder guarantees that the above named animal may be returned to the breeder within 1 (one) week of the purchase date if a problem arises with the dog's health or temperament. It is recommended that the buyer have the above named animal examined by a licensed veterinarian during this period. If a problem is found, the animal will be replaced, or the purchase price will be refunded.
4. The buyer guarantees to take good and reasonable care of this Australian Cattle Dog, providing for all of it's annual immunizations and other medical, physical, and emotional needs.
5. The breeder guarantees replacement or compensation for the following congenital defects: severely overshot or undershot bite, monorchism, cryptorchism, and height more than two inches over or under the breed standard at maturity. Upon proof of the defect and approval from the breeder, the animal is to be sterilized. Compensation will be made upon proof of sterilization with the next available puppy of suitable quality or with a refund to that of a Pet Quality pup.
6. The buyer agrees to use the prefix "Katwala's" in the registered name of this Australian Cattle Dog.
7. The breeder guarantees compensation for the development of hereditary eye problems other than prcd under the following conditions:
  - a. The above named dog's eyes are to be checked by a board certified veterinary ophthalmologist for a CERF exam prior to the breeding of this animal.
  - b. The breeder is to be notified as soon as possible about the results of the above named test. The breeder must be notified before any action is taken (ie: spaying, neutering or euthanasia). The breeder requires copies of all test reports and reserves the right to obtain a second opinion. Upon agreement that a

congenital eye defect exists, the breeder will require the dog be sterilized before refund of the purchase price to that of pet quality or replacement will be made with a puppy of suitable quality.

8. The buyer understands the genetics behind prcd in this breed and specifically of this breeding and has either opted to have the pup tested prior to purchase at their own expense or agrees to accept the pup without testing at his or her own risk
9. The breeder guarantees replacement for Hip Dysplasia under the following conditions:
  - a. The above named dog's hips are to be X-Rayed, prior to the age of 36 months , by a licensed veterinarian and sent in to the Orthopedic Foundation for Animals for rating prior to the breeding of this animal.
  - b. The breeder is to be notified as soon as possible about the results of the above named tests. The breeder must be notified before any action is taken (ie: spaying, neutering or euthanasia). The breeder requires copies of all test reports and reserves the right to obtain a second opinion. Upon agreement that hip dysplasia exists, the breeder will require that the dog be sterilized before refund of the purchase price to that of pet quality or replacement will be made with a puppy of suitable quality.
10. The buyer understands that it is the express wish of the breeder that any possible hereditary problems be found before the above named dog or bitch is bred. The buyer understands that all guarantees listed above will be null and void if this dog or bitch is bred without prior OFA evaluation and CERF exam.
11. The buyer understands that it is the express wish of the breeder that this dog be shown in the conformation ring with the goal of an AKC Championship. If the dog is agreed to be of inferior quality at two years of age or older, refund of the purchase price to that of pet quality will be made upon proof of sterilization. If there is no mutual agreement regarding the dog's quality, the breeder will replace the dog upon return to the breeder, with all ownership and rights reverting to the breeder.
12. The buyer will be responsible for all showing expenses, such as entry fees, transportation costs, handler's fees, and advertising costs (unless advertising is at the request of the breeder). The breeder agrees that if able and if requested to do so by the Purchaser, she will handle the above named bitch at mutually agreed upon AKC point shows and will do so free of charge. In such cases, however, all entry fees shall still be paid by the buyer.
13. The buyer agrees that if it should at any time become impossible to keep the above named Australian Cattle Dog for any reason, that the breeder will be contacted and offered the first right to take the animal back.
14. It is agreed that notification of change of address or telephone number will be given between parties within 10 days of such change(s).
15. The buyer guarantees that at no time will this animal be turned over to the pound, humane society, or animal shelter as a means of disposal.
16. The buyer guarantees that at no time will this dog be chained or otherwise tied out, and will not be allowed to run free unsupervised.
